BeeLeaf Diploma & Advanced Diploma in Contemporary Psychotherapy

This document outlines the professional training path from Beginning to UKCP Registration.

The **Diploma in Contemporary Psychotherapy** is made up of the following components.

* Indicates that APL (Accredited Prior Learning) may be awarded for these training modules and therefore do not have to be undertaken with BeeLeaf.

- Certificate in Skills & Principles of Contemporary Psychotherapy* *Replaces Foundation Certificate*
- Certificate in Contemporary Psychotherapy in Practice *Replaces Intermediate Certificate*
- Ethical Practice
- Human Development & Sexuality*
- Psychopathology*
- Clinical Practice and Comparative Psychotherapy including a minimum of **100 hours** of Supervised Clinical Practice (Clinical Supervisor fee not included in course fee. You are required to have **one** hour of Clinical Supervision with a Clinical Supervisor for every **six** hours of Clinical Practice with clients)

The **Advanced Diploma in Contemporary Psychotherapy** is made up of the following components.

- BeeLeaf Diploma in Contemporary Psychotherapy **OR** Diploma in Psychotherapy or Counselling Accredited by UKCP, BACP or equivalent.

PLUS

- Working Creatively with Trauma *Week 1 of Summer School*
- Working Effectively with Anxiety & Depression *Week 2 of Summer School*
- Working Successfully with Addiction & Recovery *Week 3 of Summer School*
- Research Methods and Dissertation

For UKCP Registration

- BeeLeaf Advanced Diploma in Contemporary Psychotherapy

PLUS

Those Members of BeeLeaf who have completed the BeeLeaf training pathway to Advanced Diploma are eligible for UKCP Registration, upon completing the Registration process and evidencing:

- A total of 450 hours of Supervised Clinical Practice. You are required to have one hour of Clinical Supervision with a Clinical Supervisor for every 6 hours of Clinical Practice with clients. (Clinical Supervisor fee not included in course fee).
- 100 hours of mental health familiarisation, either within clinical practice or other mental health role.
- Personal Therapy. You are required to have 48 hours of one-to-one personal therapy with a Psychotherapist or Counsellor who is UKCP Registered (or equivalent) over the 4 year training period, plus 40 hours of one-to-one or group therapy. This is not included in the course fee.

Continued...

Those participants who have joined the BeeLeaf Advanced Diploma having gained their previous qualification with another training provider, may be eligible to join the pathway to UKCP Registration and be able to claim up to 24 months and 50% of training hours as APL (Accredited Prior Learning).

Entry Requirements

- Successful completion of application form and interview
- First degree **OR** equivalent formal or life learning to benefit from BeeLeaf's policy of inclusivity

Fees

- Application Fee £50.
- Training fees *Refer to individual Courses listed above*
- Fees for personal therapy. *Budget for approximately £30 - £50 per session.*
- Fees for Clinical Supervision. *Budget for up to £50 per session or free.*
- Professional Liability Insurance. *Budget for approximately £9 - £49 per year. Applicable as soon as you begin seeing clients in private practice.*
- Annual membership fee for BeeLeaf Register, Community for Contemporary Psychotherapy. *(Varies between £40 - £120 depending on level of Membership)*
Included in training fee, exceptions when training is deferred / extended.
- Fee for UKCP Registration. *Optional annual Student (free) and Trainee Membership plus final UKCP Registration fee.*
